K.C. COUNCIL OKAYS SPECIAL REVIEW DISTRICT

On Thursday, December 11, the Kansas City Council approved the creation of a Special Review District which will allow for a board to enforce design standards for new businesses and building developments along Main Street. The board will be made up of citizens drawn from the corridor and nearby neighborhoods to review plans for commercial developments and changes. The seven voting members will be property owners or lessees in the review district.

Southmoreland Neighborhood is affected because our western border, Main Street to Walnut Street and reaching from 39th to 47th Streets, is in the new district. This is prime real estate which should have the highest quality of development.

A Special Review District establishes specific standards for an "overlay zoning district," a zoning classification that adds requirements to the normal process when building permits are sought. Among these specifics are building setbacks from the street; size of facade; coverage of lot area; location of windows and entrance; types of building materials, land-scaping, location and screening of trash and garbage receptacles; number of driveways; location and screening of parking; and location, type and size of signs. Adherence to these standards will provide protection for adjoining residential streets, and quality development will provide a progressive and attractive front door to Southmoreland on the west.

As developers share projections with our zoning committee and with the executive board before they take projects to the new Special Review District board and to the City Council, Southmoreland needs a corps of residents and businessmen who are willing to share the responsibility of studying projects, attending hearings, and testifying on behalf of the neighborhood. For many years Southmoreland has relied on a dedicated group of officers and chairpersons to represent them in this way. It is time that

additional residents volunteer to help. If you can devote some time and thought to this important phase of Southmoreland's development, get in touch with Pat Kroll, chair for zoning and development, or with one of the officers. Your suggestions and help will be appreciated as we work together for a better neighborhood.

PLANNING COMMITTEE MET TO DISCUSS S.N.A. GOALS

Five members of the goal-setting committee met December 7 to consider ideas submitted by several neighborhood members and to organize suggestions into a list that will be discussed at the January 13 meeting of the Executive Board. There is still time to submit your suggestions. Among those that will be considered are the future of the Main-to-Walnut corridor, 27th to 47th, recently included in a new Special Review District; the problems of trash, litter, and illegal signs; the problems of neglect by absentee owners or by careless tenants; ways to involve more neighborhood residents in the work of the Association; block parties to get acquainted and to plan neighborhood cooperation; ways we could support the schools; and how as individuals we can make this a crime-free neighborhood.

There are plenty of problems for us to solve; we just need your help and that of every neighbor to find the best solutions.

SNOW SEASON PROCEDURES

Whether we are ready or not, one of these days we will need to think about that white stuff. Here are some facts about snow removal in Kansas City:

Not all streets can be cleared immediately. Main streets and arterial streets carrying heavy traffic have precedence.

The city begins residential plowing where there is an accumulation of over 3 inches of snow. Plowing is contracted out on the 1500 miles of residential streets in Kansas City, Missouri. The contractors are required to plow only 12-foot paths in the middle of the road, not from curb to curb.

All residential streets should be cleared within 12 hours after a snow storm has ended. If your street has not been plowed within that time, call 274-1662. In case of a valid medical emergency that warrants immediate attention, call the Police Department at 911.

Winter Emergency Items: Keep these in your vehicle during the winter months to save inconvenience and possible expense: •ice scraper/snow brush; •tow chain/rope; •booster cables; •flashlight with extra batteries: •a box or bag of sand or gravel, shovel; •first aid kit; •overshoes or galoshes; •a warm blanket.

Be prepared for icy streets with all-weather tires or snow-studded tires.

HOLIDAY SAFETY TIPS

All the excitement of unwrapping gifts is over. The ribbons and papers are scattered from attic to basement. What to do with them, and with the tree?

Many of us carefully store the nicest ribbons or paper that might be used again. But the rest? **Do not** burn them in the fireplace, which might start a chimney fire. Bundle it up, put it into a city garbage bag, and on collection day, it will be ready to put on the curb.

Live trees are another fire hazard if put into the fireplace, where the resin in pine needles and trunk can explode in showers of sparks. If you would like to use the tree as a shelter for small wild life, tie it down to a fence corner as soon as you take it out and occasionally put an ear of corn or birdseed under it. Otherwise, cut it into four-foot lengths and tie them as you would a dead tree limb, again, to place at the curb on Monday. A few minutes of your time disposing of these after-holiday items will make your home neater and safer.

If you have lights at windows or on trees, remember to disconnect them if you leave the room.


Keep your curtains drawn when the tree lights illuminate the room; don't give an invitation to anyone looking for an empty house or holiday gifts.

SOUTHMORELAND TO SPONSOR SCHOOL INFORMATION MEETING

Plans are being completed for Southmoreland to sponsor an informational program concerning Kansas City Schools' magnet school plan. This will be held on March 10 at 7:00 p.m., the night of our quarterly general meeting.

Final arrangements will be announced in the March 1 newsletter. However, tentatively, we expect to meet at Westport Junior High School, where there is ample lighted parking off McGee, and where we can host other neighborhood associations adjacent to our area. We expect to have representatives of the elementary schools, a Board member, and other resource people on hand to explain the plan and to answer questions from the audience.

We hope to have a large attendance; this is a topic of tremendous interest that will have impact on Southmoreland's future as a desirable place to live and do business. Plan now to attend March 10, and watch for further information about the time and place.

TIME TO REGISTER FOR CITY ELECTIONS

If you have not already registered to vote in Kansas City, Missouri, you have only a short time remaining to do so before the March elections.

Requirements for voting in a city election include: you must be a United States citizen, at least 18 years old, and registered at least 30 days before the election. You must have been a county and state resident for at least 30 days. You should supply identification showing your name and address; a driver's license is sufficient.



GENERAL MEETING MARCH 12 FEATURES MAGNET SCHOOLS

The general meeting of Southmoreland Neighborhood Association will be held Thursday, March 12, at 7 p.m. in the auditorium of Westport Junior High School Please note the **change of day**.

The purpose of the program will be to provide information about the magnet schools that will be functioning in the next school year. A panel of three education-oriented speakers will describe the plan and its implementation. Arthur Benson, III; Mrs. Mary Arney; and Mrs. Rayna Levine, Principal of Volker School where some Southmoreland children are students, will give us an overview and take questions from the audience.

Good schools that meet the needs of students and community are essential. Several other neighborhood associations have been invited to attend. We urge you to make it a priority. There is ample parking on the Westport Junior High School lot directly across the street from the entrance on McGee.

As a part of the general meeting, Southmoreland committees will report on the progress of the neighborhood signs that will soon be installed; the pamphlet that is in the development stage, to be distributed to encourage new residents and further development; and the cleanup committee's plans for a litter pick-up day.

There will be an opportunity to pay your membership dues if you have not already done so. The membership year extends until October 1st.

There is a lot going on in Southmoreland Neighborhood. Get out a pencil, check the date March 12 on your calendar, and meet your neighbors at Westport Junior!

LARGE TRASH PICKUP APRIL 6

It's time to get at that garage, basement, and attic if you will have large articles to be picked up in the city's large trash collection Monday, April 6.

All items must be placed beside the curb. Loaders will not collect items left on porches, sidewalks, or driveways. Place loose items that might scatter in boxes, garbage bags, or tie them tightly in bundles.

Tree limbs or odd pieces of lumber must be cut into four-foot lengths and tied with twine or wire.

Trash should not be put at the curb before 4 p.m. on Sunday. Collection begins at 7 a.m. and will continue until all trash has been removed.

If any loose paper, broken crockery, etc., is left behind, get it ready for the next regular pickup. Let's keep Southmoreland clean!

AREA POLITICAL ACTION GROUP MAKES ENDORSEMENTS

A newly formed, neighborhood-based organization of 150-plus members, the Westport Citizen's Action Coalition, (WCAC), made its endorsements for Mayor and City Council recently. The group does not represent any neighborhood association, but includes members from Westport's fourteen neighborhoods. It is independent and non-partisan.

WCAC was started by neighborhood leaders because they felt Westport did not have the political clout it needs and because many other area political organizations have not been involved in solving critical problems. In addition, many are heavily influenced by money from candidates and their organizations. WCAC accepts no money or contributions in kind from candidates or their organizations.

WCAC endorsed Mayor Richard Berkley; for 2nd District City Council At-large, Frank Palermo; for 2nd District City Council, Pat Shaughnessy; for 4th District At-large Council, Katheryn Shields; and for 4th District City Council, Dan Cofran.

AUTO HITS URN: URNS WINS

A careening automobile leaped over the curb into the narrow park that separates Rockhill Terrace and 43rd Street at Oak early Saturday morning. Unfortunately for driver and car, it hit the monumental concrete urn that ornaments the park at that point. The impact sent the upper vase part of the urn flying to the ground. It also sent those in the car (one or more) to the hospital in an ambulance after half a dozen police cars converged on the scene. Damages for repair of the urn will be sought.

The repair of the urn and replacing it on its pedestal is a matter for the K.C. Department of Parks, on whose property it was located. Dieter Trost gave the urn to the association while he was a resident here, and it was then placed in the park. It is quite an antique, not easily replaced. Association members, including Pat Kroll most recently, kept it filled with vines and flowers. We hope it will be ready for the traditional May planting.


TRASH AND LITTER DAY EVERY DAY

The festivities will begin at 6 p.m. to allow folks to get there after work, and the food will be ready about 6:30. This will be a potluck meal featuring your contributions--- casseroles, vegetables, salads, hors d'ouevres, and desserts---with fried chicken being supplied by our friends at Jackson County Bank. Cold beverages will be on hand and paper plates, cups, and plastic tableware will be furnished.

In case of a pouring rain, June 16 will be a backup date. But let's be optimistic and expect a sunny, gorgeous June day on the ninth, and we'll see you there!

ST. PAUL'S BEGINNING EXPANSION AND RENOVATION

Kent Maughan, business manager of St. Paul's Episcopal church, an anchor of the neighborhood at intersection of Main Street and 40th Street, shared plans for the renovation and new construction that will be undertaken at the church beginning this May, when he met with the Southmoreland Board, April 14.

The Gothic gray stone church, built in 1906, will be made accessible to the handicapped through the modification of the entrance on the south side and the addition of elevators that will service all four floors. A roofed drivethrough entryway from Walnut to the parking lot and Main Street exit will be the new entrance for most purposes. On the northwest corner, a garden room will add interior space for special activities, and modifications affecting about 19,000 square feet will provide space for an infant nursery room and early childhood center, an art center, and a teachers' work area. The plans will make it possible to have all young children on the lower floors of the building.

Further plans call for a new multipurpose building north of the

church school formerly known as the old Rollins School. The building will provide for a gymnasium, stage, and eventually a dining hall, libraries, and meeting space. The long-term project will require about \$3 million for completion.

The Southmoreland Association is pleased to have this historic place of worship within our neighborhood and look forward to seeing their plans take shape.

SOUTHMORELAND NEWSLETTER DELIVERY TO BE CHANGED

Do you sometimes consign your newsletter to the wastebasket without reading it? Do you ever get upset because you do not get a newsletter, although you have paid your membership? Does your newsletter arrive too late to make use of the information it contains? Whatever your category, be aware that a change is about to happen.

For several years, the association has paid for having 1800 newsletters printed. A distribution team has written copy, gotten it to the printers, counted, bundled, and delivered for the 40 carriers, and then they have delivered their assigned routes.

Sometimes the system breaks down. It is nearly impossible to locate volunteers to 1) write the copy, 2) get it from printer to carriers, and 3) carry it to houses and apartments. At least five requests for help made in the past year have gone unanswered.

Your officers have voted to handle the problems in a different way. A bulk-rate mailing rate has been secured through Westport Tomorrow. Beginning June 1, the newsletter will be mailed at this bulk rate to all paidup members. Everyone whose membership is paid as of May 28 will receive this service.

If you are not a member of the Southmoreland Association but would like to have a copy of the newsletter, the following drop-off points have been arranged, and approximately 100 copies will be delivered to each point as near the first of the month as possible. (We cannot provide additional copies.) You can get your copy at J and G Grocery, 43rd and Oak; Kenneth's Hair Fashions, 43rd and Oak; Merchants Bank, 43rd and Main; Quik-Trip, 39th and Warwick; Quik-Trip, Main Street; Old Westport Cash Saver, 40th and Main. Sophian Plaza and Oak Hall will have delivery

for the use of the residents there.

The procedure will be evaluated after six months. We ask for your cooperation, and we hope you will become a paid member and share all the benefits of the Neighborhood Association. An application is printed on the back page, and Eddie Edmondson, Treasurer, 4317 Oak, will be glad to put you on the membership roll.

CAPITAL IMPROVEMENTS MEETING

Residents of the Kansas City Council 's fourth district have been asked to suggest capital improvement projects for their neighborhoods. Southmoreland Executive Board has decided to ask for curb and gutter repairs, street lights, shade trees on parking lots, and permanent containers to hold trash barrels. The president and others will attend an April 23 meeting to present these requests.

The improvements lists of all districts will be combined, prioritized, and presented to the voters in November when a funding proposal will be on the ballot. This funding would supplement the city's half-cent public improvement sales tax, which is in its fourth year. The requests made by neighborhoods cost at least 10 times as much as the \$20 million the sales tax raises annually. This would indicate that there are some hard choices to be made---the improvements have their price.



WIDE RANGE OF LEARNING OPPORTUNITIES AT ART INSTITUTE

A wide range of learning opportunities for artists of all ages is being offered this summer by the Kansas City Art Institute's continuing education program.

Forty-eight courses, ranging from credit classes to non-credit workshops to high school workshops and young artist programs will be presented over the sixweek period of June 8 to July 17.

For the first time ever the Art Institute is hosting a summer studio residency program for high school juniors and seniors in two 2-week sessions, June 14-27 and June 28-July 11.

High school workshops will be held on weekday mornings coinciding with the high school summer studio residency program.

The young artist program will be presented in three sessions offering programs in mixed media drawing, relief printing and inflatable sculpture. The young artist program is for students entering grades 4th through 8th.

The college is also offering graduate courses in painting and photography this summer. An advanced photography class on intensive investigation into personal imagery will be taught by Gary Sutton, a professor in the college's photography department.

A painting course dealing with alternative approaches to image making will be taught by Shirley Luke Schnell, also of the KCAI faculty. The graduate courses will be presented June 8-26.

Continuing education students have access to all campus facilities including the 33,000 volume library and slide library; the media center which provides technical services and instruction in the use of audio, visual and multi-media equipment; and the art supply store offering a wide range of materials and supplies for studio

classes as well as books on art technique, art history and literature.

Included were completion of the curbs and gutters south on Warwick to Brush Creek, additional street lights, parking shade trees, and permanent trash barrel containers.

Recently, the Parks Department has advised that funds are available to complete the curb-gutter project this summer and to install a traffic island at the intersection of 45th and Warwick. This improvement is much needed. Placed as the intersection is, opposite the entrance to the K.C. Art Institute, and adjacent to the music building, All Souls Unitarian Church, and the new commercial developments on Main and 45th, the traffic flow has more than doubled. The lack of direction for north-bound traffic on Warwick makes driving there as exciting as the Indy 500. We commend Parks for their interest. NELSON-ATKINS MUSEUM OF ART PLANS HENRY MOORE SCULPTURE PARK

Nine monumental sculptures and two to four working models by the late English artist, Henry Moore, will be situated in a newly designed park adjacent to the Nelson-Atkins Museum. The Henry Moore sculptures are on long-term loan to the museum from the Hall Family Foundations' collection.

The site consists of 36 acres extending south from the Museum to Volker Boulevard, and from Rockhill Road

to and including Southmoreland Park.

Deborah E. Scott of the Museum will be Curator, and the sculpture park will be overseen by the Kansas City, MO Board of Parks and Recreation Commissioners. Prior to the completion of the sculpture park in Fall 1988, seven of the largest sculptures will be placed for preview at sites throughout Kansas City. Already in place are The Sheep Piece and Relief No. 1 at the Nel-

son-Atkins Museum. Other sites are KCI Airport, City Hall, Loose Park, Swope Park Zoo, and the Nelson-Atkins Museum. The works will be installed the summer of 1987.

MEMBERSHIP DRIVE CONTINUES: WHAT'S IN IT FOR ME?

Treasurer Eddie Edmondson reports that 14 new memberships were received through May 12. We hope to reach 200 paid memberships by June 9, when you can pay your dues if you have not yet done so.

Recently, a neighborhood resident asked, "What does the Association membership do for me?" Here are


The Association, through its officers, committees, and contributing members, communicates with city officials and boards and then brings the information back to the members and residents. Last year, former president Suzi Lockett and the signs committee chair, Wolfgang Trost, worked through a maze of boards, rules, and fabricators to get Southmoreland street markers that will show the boundaries of this neighborhood. This is a project that is being encouraged for other areas.

As a result of persistent efforts to stop the placement of signs for musical groups, tavern entertainment, yard sales, and other announcements, mostly from outside the area and placed on city property, utility property, and residential streets, city officials are cracking down on offenders. Suzi has led the opposition to this form of littering with the help of her family and others, removing signs and writing letters to the editor. We can all help by 1) removing the offending signs which trash our neighborhood, and 2) obeying the law---no signs of our own except on our personal property.

The trash and garbage ordinance sets out specific times

and conditions for placing newsletter has publicized these regularly, and the area is cleaner and more attractive as a result.

The officers or their proxies try to attend all meetings at City Hall that directly affect Southmoreland. These include zon-



ing hearings. Residents who ask for advice on tenant violations or landlord violations are directed to the appropriate agencies. The officers and chairpersons form the nucleus of the litter clean-up group that meets the first Saturday of each month and removes litter for at least two hours.

When a building or renovation project is being planned in the neighborhood or adjacent to it, the developers meet with the board to describe plans and listen to our objections or suggestions. These reflect the opinions of our residents.

The Association extends communications throughout the area through its quarterly meetings (October, December, March, and June), public forums such as the school informational meeting held at Westport Junior High in March, and the newsletter. Area newspapers are informed of upcoming events. All city offices receive the newsletter, and communications from the city are reflected in its articles.

In these ways, your Association works to keep in touch with events and actions that affect our neighborhood, to pass the information on to you, and to articulate your wishes to our local officials.

The dues for the Association pay for publishing the Southmoreland newsletter, for stationery and postage, and for minor expenses at quarterly meetings. No officer or chairperson is paid. All are volunteers who are contributing up to 40 hours each month because they have the goal of a better place to live. If you are a paidup member, thank you for your continued interest and support! If you are a paid-up working member, giving of your time as well as dues, a double thank you! And if you aren't a member but think Southmoreland Neighborhood Association is really worthwhile, won't you send your dues to Eddie Edmondson today?

K.C. NEIGHBORHOOD ALLIANCE MAKES POSSIBLE OUR NEW LOOK

The newsletter which you are reading was produced at the Kansas City Neighborhood Alliance with the use of a MacIntosh Plus Computer and a Royal 1803-Heavy Duty Copier. The new four-page format, graphics, and variety of type are just one example of the designs that can be obtained with this equipment.

K.C.N.A. administers the Neighborhood Small Grant Funds which assist more than 50 Kansas City area neighborhoods in revitalizing projects. The Center is located at 616 W. 26th Street and is directed by Jessica Henderson.

The Southmoreland Board has given careful consideration to using the newsletter services of the Alliance for several months. At the May 12 meeting, the Board voted to try the plan, which involves having several persons trained in using the equipment and producing the newsletter at the Center. Ruth Harbour suggested that Tricia Collier be asked to become one of our trainees and volunteered to take the training also. The two women have taken part in two sessions, and Tricia is responsible for typing this newsletter into the MacIntosh Computer, with Ruth responsible for writing and for mailing.

Besides the flexibility which the new system offers in the way of size and format, there is a saving in cost. Because of the grant funds, the Alliance, a not-forprofit corporation, provides free training and use of all equipment. The newsletter costs will include paper over 1200 copies and the bulk mailing charge of seven cents per copy. We will have a nominal fee each month for the services of our computer typist. We estimate savings of about one-half our previous monthly

If you like the new format, please say so! If you do not, call and tell us how to improve. And if you have time on your hands, we would be happy to enroll you in the training program or accept your help in getting the paid members' copies into the mail.

ART OF THE '50S AND '60S TO BE SHOWN AT THE NELSON-ATKINS

The major exhibition Made in U.S.A.: An Americanization in Modern Art, the '50s & '60s makes its only Midwestern stop at The Nelson-Atkins Museum of Art, Kansas City, Missouri, from July 25 through September 6, 1987. Included in this exhibition of over 100 paintings and sculpture from the years following Abstract Expressionism are two of The Nelson-Atkins's celebrated works, Tracer, 1963, by Robert Rauschenberg, and Still Life #24, 1962, by Tom Wesselmann. 

DATES SET FOR WESTPORT NEIGHBORHOOD CLEAN-UP

Westport Tomorrow will again coordinate the neighborhood cleanup with the Public Works Department for the Westport neighborhoods. The area has been divided into three sections for pickup of bulk items the last week of July and the first two weeks of August. Southmoreland will be a part of the August 10 large item pickup.

Bulk items must be curbside by 7:00 a.m. on Monday of the week (August 10) for Southmoreland. If all collections are not made on that Monday, collection will continue on Tuesday until all collection routes have been completed. However, routes will

not be repeated.

To make the most of this service, follow these rules: (1) Items must be placed on the parking next to the curb, not left on the driveway or next to the house or apartment; (2) Loose items must be placed in containers that can be handled by the men loading the truck, not allowed to lie loose on the parking; (3) Tree branches and limbs should be cut into four-foot sections and tied together in bundles; (4) Put the items at the curb after 3:00 p..m. Sunday and before 7:00 a.m. Monday.

Here is a tip from the Volker View newsletter: a little ammonia in trash bags will help keep dogs and cats from scavenging.

Why not start now to organize your basement, garage, and attic so that you will get rid of those bulky items that are crowding your storage areas? Then, come August 10, you'll be ready to join in the neighborhood cleanup.

ENJOY A WALK THROUGH SOUTHMORELAND

If you are a walker, Southmoreland neighborhood has many treats in store for you. Everywhere, beautiful trees are in their best form. The variety of sizes, shapes, and color is beautiful. Many young trees have been planted in the parking, and residents have added ornamental trees in their yards.

As you walk down Main Street near 41st beside Hardee's, observe the new Southmoreland sign on the right, facing Main.

If your walk takes you down Warwick from 39th Street, check out the many home improvements that have been made. Fresh paint, concrete drives, and plantings have given a new look to many homes. The apartment buildings are very attractive too.

Angling west on 43rd, note the refurbished facade of the Bremson Building, now known as Walnut Place. New businesses there are a fine laundry and Domestic Aides, a cleaning service.

Moving east on 43rd, stop to enjoy the flowers planted in the urn at the tiny park on Oak at 43rd. Thank you, Eddie! The planters in front of the shops on 43rd are filled with blooms and add a bright touch of color that sets off the newly painted exteriors.

As you stroll or jog, take note of the color and beauty that is evident all through our neighborhood. It will brighten your day.

CRIME PREVENTION REQUIRES PLANNING AND COMMON SENSE

This is the season when residents are most vulnerable to break-ins, purse-snatching, assaults, and other crimes. Sometimes we become careless because we are in a hurry or because of the heat. Here are a few suggestions that may prevent your becoming a

(1) If you live alone in a house or apartment, do not put your first name on your mailbox; use your initials or last name only.

(2) Do not give unnecessary information to a stranger who calls on the telephone. Sometimes break-in artists are verifying whether your home will be occupied. Never state that you are going away.

(3) If you go on vacation, make arrangements to have your lawn mowed, the garbage placed at the curb, and the newspaper stopped or picked up by a neighbor. Automatic lighting inside is useful too.

(4) Do not leave a note on the door stating when you will return if you leave the house. Do not leave your key under the door mat or in your wall mailbox. Try to arrange deliveries at times you can be at home, or ask a neighbor to accept delivery for you.

(5) Never open the door to a stranger. Ask for identification of a workman whom you expect before admitting him.

(6) If a stranger asks to use your telephone, direct the person to the location of street telephones in your neighborhood. Do not admit a stranger! A hard-luck story may just be bad news for you.

(7) Keep your windows closed if possible; have them "pinned" so that they cannot be raised from outside. Police say that the double protection of

closed storm and window discourages many would-be prowlers. Do not leave doors or windows unlocked, especially at night.

(8) Call the police if your house appears to have been entered; wait until they arrive before you enter.

(9) When walking or driving alone, be alert if you appear to be followed. Proceed to the nearest lighted home or area to get help.

(10) Know your neighbors! Exchange telephone numbers and pay attention to suspicious activities outside your homes. Remember that good neighbors care about each other--be a good neighbor!

ATTENTION CAR OWNERS: NEW FINANCIAL RESPONSIBILITY LAW

Beginning July 1, Missouri law requires you to have financial responsibility for motor vehicles you own. On or after July 1, you will be required to sign a statement when you register your vehicle. The statement, once you have signed it, will certify that you have and will keep liability insurance or other type of financial responsibility for each motor vehicle you own.

Any questions you may have are to be directed to your insurance company or the Missouri Department of Revenue, Post Office Box 200, Jefferson City, MO 65105.

THE METRO SENIOR CITIZEN CARD

If you are 65 or older and have a Medicare card, you can ride for half-fare on all regular Metro service (including Chiefs and Royals expresses) simply by showing the Metro driver your Medicare card.

If you don't have a Medicare card, call the Metro Information (221-0660) and ask for a Metro senior citizen reduced farecard application. Mail the application along with a certified copy of your birth certificate to The Metro. Do not mail any other form of identification. (You may bring your application with your birth certificate, driver's license or passport to The Metro's general offices, but no cards will be issued over the counter.) Bring or enclose \$1 cash or money order (no checks accepted) for your registration fee. Allow ten days to receive your card by mail.

The date for the 4th annual National Night Out is August 11, 1987. This is a coast-to-coast crime prevention project designed to (1) demonstrate the value and effectiveness of police-community prevention programs; (2) generate support for and participation in local crime watch organizations; (3) strengthen neighborhood spirit in the anticrime effort; and (4) send a message to criminals letting them know neighborhoods across the USA are organized and watching.

In Southmoreland, we ask that every resident take these steps to show support for anti-crime efforts. It is a fact that knowing your neighbors and looking out for each other's property can deter crime. So first, please meet your neighbor on either side and exchange greetings and names, if you do not already know each other. Second, plan to sit on your front porch, steps, or the lawn, from 8:00 until 9:00 p.m. (Have your back door locked and windows secure!) If you have a flashlight, carry it with you to shed light when needed. At 8:30, turn on all your exterior lights and enjoy the spectacle of a well-lit neighborhood.

Some of you may wish to carry your observance further--a picnic, sparklers, a cool beverage--and if you and your neighbors come up with something with pizazz, have fun!

Kansas City Night Out is intended for everyone. Neighborhood organizations may compete for the most original observances. City Hall is working on promotion. The media will be out in force to record and broadcast. The most important message we can get across is that we are a united group of citizenry who want to do something about the minor and major crime that reaches down into our backyards and the streets in front of our homes. We have had incidents of breaking into automobiles, entering basements, and prowling this summer. It is important tht we assert our determination to keep our homes and neighborhoods free of crime. So, get set for K.C. Night Out! Let your light shine!

BOARD MEETING JULY 14 REVIEWS PROGRESS, SETS CALENDAR

Meeting at the home of Eddie Edmondson Tuesday night, July 14, officers and committee chairpersons heard reports of committees and made plans for coming events.

Suzi Lockett, reporting for the Signs Committee, described the installation, dedication, and final costs of the project. Seven signs were fabricated for \$2,807.76. Six of these are in place, and the seventh is held for another installation spot. The group commended Wolfgang Trost, who designed the signs, Suzi Lockett, and Eddie Edmondson, Treasurer, who stayed with the project until it was completed.

A letter objecting to the improper use of a basement being used as a fourth apartment was read. The Association will investigate further and recommend that the instance be referred to City Codes and Zoning.

Chairman Evalyn Lee reported a successful trash and litter cleanup on July 11. In spite of the extreme heat, Evalyn, Dennis Pierce, and Eddie Edmondson were on hand to supervise the work of a team designated through Neighborhood Development Program and Sam McCorvey. These workers, supervised by neighborhood residents, are available to assist on Saturday mornings in such projects. Thank you, Sam!

Reporting for the Landlord-Tenant committee, Bob and Debbie Thompson explained a few of the calls they have received concerning both sides of rental properties' problems. Other calls with complaints included failure to provide for safe premises-no smoke alarms, no porch lights, inadequate locks; invasion of privacy--owner entering premises without notice, leaving apartments unlocked on leaving so that property is damaged or missing; doing repair work that interferes with tenant's living as usual; and tenants' failure to observe trash removal, etc. The responsibilities of tenants and landlords may be the topic for discussion at the October general meet-

ing. Get in touch with your officers if interested.

During new business, Eddie Edmondson distributed the newly completed Southmoreland brochures, a project which continued the special funding received from Neighborhood Alliance. The brochures, featuring four-color covers of neighborhood homes, apartment buildings, businesses, and other landmarks, and descriptive text, will be used to promote home buyers' and developers' interest in Southmoreland as a place to live and work. This brochure, first planned by a committee made up of Ruth Allen, Ruth Harbour, and Eddie Edmondson last July 1986, was completed with the assistance of Pat Kroll, who was appointed when Ruth Allen was unable to serve. The committee was complimented on an attractive and persuasive document the presents our neighborhood well.

Discussion continued on planning for Kansas City Night Out, Tuesday, August 11. (See special article.) A nominating committee for 1987-88 officers was named: Pat Kroll, Eddie Edmondson, and Susan Trost. Their nominees and others nominated from the floor at the October 13 general meeting will be voted upon at that meeting.

At the request of the editor of the newsletter, the board voted that the September 1 issue of the Southmoreland News be combined with the October 1 issue, to be distributed or mailed October 1. The August meeting of the Board will be held Tuesday, August 11, at the home of Susan Trost. Members are always welcome to attend.

TENANTS AND LANDLORDS, YOU HAVE RIGHTS... IF YOU ARE WILLING TO LEARN ABOUT THEM AND USE THEM! - Bob Thompson

During this year, we have had several requests for information pertaining to "Landlord-Tenants Rights." Common reasons for these requests are:

- 1. Pest Control
- 2. Upkeep of Property
- 3. Trash Removal
- 4. Owners or their representatives entering the rental property without cause and without prior notice to the tenant.

The relationship between the landlord and tenant does not end at the time one pays rent to the other. Both parties should be concerned about the condition of the property; the landlord, because it represents an investment and the quality of the property

reflects his or her sense of responsibility to the tenant and to the neighborhood.

The tenant should share the landlord's concern, since he or she also has a financial investment in the property when the rent is paid. The rented property is the tenant's home and deserves the same care as one the tenant may eventually own.

Many confrontations between the landlord and the tenant could easily be prevented through communication and corrective action.

We of the SOUTHMORELAND NEIGHBOR-HOOD ASSOCIATION, share your concerns. We cannot represent the cause of the tenant nor that of the landlord in a dispute. We can, however, direct involved parties to the proper city agency.

We encourage your membership in the neighborhood association. You may find you have much in common with the group.


GET SET WITH BULKY ITEMS FOR PICKUP AUGUST 10

We have the opportunity to dispose of large items again on Monday, August 10, when Southmoreland will join with all the Westport area in a neighborhood cleanup. (Some other parts of the Westport area have different dates.)

Follow the guidelines given in the July newsletter: place items on the parking next to the curb; place loose items that might disintegrate or blow away in trash bags or cardboard boxes that can be covered, cut tree limbs or branches into four-foot sections and tie in bundles, and put the items at the curb after 3:00 p.m. Sunday and before 7:00 a.m. Monday.

Note: Kansas City, MO, residents may dump pick-

ups or trailers hauling large items in the Laid-law landfill at 83rd and Indiana (85th and 71 Hwy) each Saturday for the special fee of \$2.00 per load. To get the special rate, the vehicle must have a city sticker, the trash must be covered, and the trailer must be 14 feet or less. Hours are 8:00 a.m. to



5:00 p.m. This may be a convenience if you are remodeling or disposing of many large items.

CITY SERVICES MOW AND CLEAN UP UNSIGHTLY WEEDS AND DEBRIS-COVERED LOTS, BUT THE OWNERS PAY

There are 14 vacant lots in the Southmoreland Neighborhood, bounded by 39th and 47th Streets, Main and Gillham-Rockhill Roads. In some other locales, these might be grassy areas where people walk or children play. Not so on these 14 lots. They are for the most part ugly eyesores that offend residents and passersby. They are owned by absentee owners who don't have to look at the hemp, sourdock, crabgrass, wild carrot, wild onion, and poison ivy that are rampant on the lots.

Others have suggested planting colorful plantings. Such proposals have merit, but the decision is up to the owner.

A REMINDER FOR EVERYONE

Have you heard the screaming sirens as fire engines race toward the site of another house or apartment fire this summer? According to the published reports, summer is not a time when we can relax our worries about fires that destroy property and kill or injure people.

Three facts stand out in reports of fires. First, *children* are curious about fire and play with lighters and matches. Second, *smokers* who are careless may set furniture or trash receptacles on fire. Third, thoughtless *management* of cooking oils and open flame stoves creates an explosive situation. These are major causes.

We all need to take adequate safety precautions so far as children's access to flammable items-matches and lighters. Smokers who smoke in an easy chair or in bed have a personal responsibility to keep themselves from going up in smoke. Attention to what's cooking can eliminate grease fires. Let's give the firemen a break this summer!

Another fact is often mentioned when a fire breaks out suddenly, and it is something we can all control. When there is no smoke alarm, or a faulty smoke alarm has been neglected, the warning that might alert residents and save lives is missing. City ordinances require that all owners install and maintain smoke alarms. If the owner of your building has not installed alarms, speak to him next time you pay your rent and insist that alarms be installed. Then help maintain them. If you live in a house you own, check on your smoke alarms to be sure they are in working order. Your life may depend on it!
