IN SYMPATHY



MISSOURI WEATHERIZATION PROGRAM

There are two ways to obtain help on getting your home caulked, weatherstripped and insulated, and free weatherization materials and installation for qualified low-income residents or low-interest weatherization loans to any Kansas City, Missouri homeowner served by the KPL/Gas Service Company, REGARDLESS OF INCOME.

You have to apply and then qualify for this program, but if you are interested, call or stop by the weatherization office at 3410 Troost or call 561-9500.

COMMUNITY SERVICE WORKERS PROGRAM

The Community Service Workers program is designed to assist the citizens of Kansas City, Missouri, through neighborhood organizations and community agencies, to abate property maintenance and nuisance code violations or potential code violations. The community service workers are individuals who have been referred by the Municipal Court, because of violations of municipal laws, to contribute their labor for a specified number of hours to benefit the community.

The program is jointly sponsored by the Neighborhood Development Department and the Urban Community Services Department, Office of Probation. This program benefits neighborhoods by maintaining the value of property, abates code violations, improves the appearance of the area, causes other homeowners to maintain their property, assists elderly and handicapped individuals, and it's free. Participants can provide clean up and limited exterior painting and minor home repair services to requesting neighborhoods, in return for the neighborhood providing supervision of the workers.

WHERE THERE'S A WILL

Why let the courts decide what to do with your property after you are no longer around? Make a will-no matter how small your assets. And while you are at it, don't forget to name the Southmoreland Neighborhood Association to receive a specified sum, too. It would be nice to have the good work of the association carried on, and to know that your neighborhood is better for your having been here and cared.

LET'S SHAPE UP

In order to be more neighborly, the board will make an effort to contact homeowners concerning problems on their property. We will wait three weeks after mailing the notices before contacting the Action Center for violations. This should be enough time to begin to take care of the problems sited by the board.

The association does not make up the ordinances that pertain to property maintenance, the city has the ordinances on their books. We do expect property owners to keep their property in respectable condition. If there is a valid reason for disrepair, then the board should be notified as soon as possible.

The ordinances pertain to exterior condition of the structure, environmental hazards concerning debris on the property/lot, abandoned vehicles and repair of vehicles on residential streets, loose animals, suspected drug houses and excessive noise.

If you suspect that your property is in some kind of violation, contact the board and let them know when you expect to begin correcting your problems; otherwise, expect to receive a notice from the board, soon.

TRASH DAYS AND REGULATIONS

Many of you decided not to listen to the radio or read this paper or the main paper in Kansas City when you were told not to put your trash out on Monday, Jan. 20th because it was a holiday.

Now there are no holidays in February. You may put your trash curbside after 7:00 a.m. on each Monday. Please listen: **On Monday** - Not the Sunday before or any other day of the week - only on **Monday Mornings** after 7:00 a.m.

The trash collection crews have to cover 316 square miles of city and make more than 143,000 stops each week. They are not going to stop at your curb to pick up your trash except on Monday mornings unless you specifically call Large Trash Pickup at 274-1811 to make arrangments.

Here are some guidelines for preparing your trash:

Trash must be on the ground at the roadside and not behind a fence or other obstruction.

Trash and other disposable items should be put outside by 7 a.m. on our collection day, but please don't put them out the night before. They could get scattered before haulers reach them.

Trash in plastic bags should be limited to 65 pounds per bag, and each bag should be securely fastened with a wire tie. Scattered trash should be gathered and placed in trash bags.

For the safety of your hauler, don't mix broken glass, needles, nails or other sharp objects with the trash you put in plastic bags. To avoid possible injuries to haulers, wrap such items heavily in newspaper or box them separately and put them at curbside.

Burn-producing or flammable liquids such as battery acid, lye, turpentine or motor oil should be separated from the trash, put in leak-proof containers, and put at the curb.

Don't put trash and garbage out for collection in trash cans or barrels that you want to keep. They could get hauled away. Place only disposable containers at the curb.

Small tree limbs and lumber scraps should be tied in bundles no more than four feet long and two feet thick. Grass clippings, stump chips and yard trimmings should be stuffed in boxes or sturdy bags.


What can't be collected? The city will not collect car bodies, large tree limbs, large or excessive amounts of debris from the construction or demolition of a building. If you are not certain whether the city will haul something away, call 274-1811.

VOTE APRIL 1 VOTE

On April 1st, the Library will be seeking voter approval of an 18¢ increase in the public library levy. This increase is vital to the future of the library and the services it provides to all district residents.

The increase (costing the average district resident less than \$20 per year) will provide an additional three million dollars to the library budget to: build four new full-service branches and establish other service outlets to serve the residents of the enitre district; provide two million dollars for the purchase of new and retrospective books for the library collection; and fund and maintain an online catalog which will provide equitable access (from any point in the system or from a home computer) to the entire collection of the library.

T-SHIRTS

There are still just a few T-shirts left, and we are on count-down. Here is what is available: children's sizes 6 - 8 (3 shirts) and children's size 10 - 12 (2 shirts). Children's sizes cost \$5.00. In adult sizes, for \$8.00 each: medium (2 shirts) and extra large (9 shirts).

CITY STICKERS

City stickers are now on sale for Kansas City residents who own motor vehicles, including motorcycles and trucks.

The sticker prices range from \$2 to \$12.50, depending on the vehicle. The sticker is required on any vehicle that is driven or parked on city streets.

A penalty of \$1 is effective April 1st for all vehicles without a sticker. This penalty increases 50c each month after April to a maximum of \$5.

The closest locations to purchase a sticker would be the Westport Bank or Merchants Bank on Broadway.

Now you may check out a videocassette tape with your library card and one dollar for a three-day period. The films are of old classics and new releases with a good and varied selection.

SNOW REMOVAL

The Public Works Department is trying to keep streets clear to maintain a smooth and efficient flow of traffic throughout the city.

On residential streets, snow plowing will begin when there is an accumulation of over three inches of snow. There are 1500 miles of residential streets in Kansas City, Missouri. Contractors are required to plow only paths in the middle of the road, not from curb to curb. They hope all residential streets can be cleared within twelve hours after a storm has ended.



POST NO BILLS

Kansas City Missouri General Ordinance Sec. 2.2 states: "It shall be unlawful for any person . . . to place, print, nail, tack or otherwise fix or fasten any card, placard, banner, bill, handbill, sign, poster, advertising, notice or other paper . . . on any curbstone, lamppost, street or sidewalk surface, pole, bridge or tree upon a public street . . . or other public property within the city."

The neighborhood would like to see this ordinance enforced. Please call the Action Center, 274-2222, to report this abuse. Be able to give them the location of the pole (tree, or whatever) that has signs posted — an address would be good if it is near or in front of a location that has an address — and if the sign has an indication of who is posting them, be sure to tell Action Center.

We know who the major offenders are, but would like a neighborhood free of trashy poles, etc. Help us clean up Southmoreland by calling Action Center. Perhaps a campaign like this will let the Codes Administration know that we are serious about enforcing the ordinance. Remember: You do make a difference.





This past month many of you have joined the effort to attend hearings at the Board of Zoning Adjustment (BZA) to support issues of concern to the neighborhood.

On May 27th, Ken Childress, owner of the building at 308 E. 43rd St., allowed to have his building become office space for a group of women who wish to network as a not-for-profit group. This means that he will never be able to have it as a retail operation again. We applaud Mr. Childress on his decision to upgrade the neighborhood in this manner. We appreciate his perception of how he can improve life in Southmoreland.

On June 10th, another BZA hearing is scheduled. 100-110 E. 43rd St. is owned by Metzger Realty. Their intention is to have a carry-out pizza parlour and a carry-out delicatessen. The Association is opposed to this building being used as retail because we feel that there isn't sufficient parking and will create a traffic nuisance. This year Southmoreland asked for and received half-cent sales tax monies amounting to approximately \$181,000 to complete curbs and sidewalks on the west side of Main Street from 39th Street to 41st Street; Warwick Blvd., on the east and west sides from 44th St. to 45th St.; 45th St. from Warwick Blvd. to Oak St.; and Oak St. from 44th to 45th St.; also to repair the monument and improve the area at the Major Murray Davis Park, 40th St. and Main St.



The ordinance covers firecrackers, squibs, cherry bombs, grenades, torpedoes or ANY OTHER COMBUSTIBLE FIREWORKS WHATSOEVER!! It is illegal to throw or otherwise deposit (or attempt to) at or near any person or motor vehicle. If you are reported for throwing fireworks, you could find yourself in court facing an expensive fine or a jail sentence, or both. If that sounds like too high a price to pay for the pleasure of using firecrackers, just think about the even higher price you might have to pay if your child loses an eye from a cherry bomb, or your house burns down from a bottle rocket which lands on the roof! Please, DON'T ASSUME THAT THE FIRECRACKERS YOU USE AREN'T BIG ENOUGH TO CAUSE THIS TYPE OF DAMAGE. Unless you are a pyrotechnic expert who has obtained a permit from the city to use fireworks, YOU ARE NOT ENTITLED TO USE FIRE-WORKS. Keep our neighborhood safe: for your holiday pleasure, attend one of the many local fireworks displays in the metropolitan area which are free or inexpensive, and provide more spectacular results than are possible in your front yard!



SOUTHMORELAND RECEIVES GRANT

Following is a list of the issues upon which you will decide. This is merely a service to our residents, it is your responsibility to study the information regarding each issue before going to the polls. Having this list handy will perhaps save you time in your selection process of August 5th.

CONSTITUTIONAL AMENDMENT NO. 2
Submitted by the 83rd General Assembly (First Regular Session) Any bill enacted by general assembly and not signed, vetoed or returned by governor within prescribed time limits shall become law. Proposal would have no additional cost for state or local governments.

CONSTITUTIONAL AMENDMENT NO. 3

Submitted by the 83rd General Assembly (First Regular Session) Establishes cash operating reserve fund in state treasury. Provides for transfer of moneys to and from fund, and for investment of moneys not required for current operations. This proposal would have no effect on the total amount of state funds.

CONSTITUTIONAL AMENDMENT NO. 4
Submitted by the 83rd General Assembly (Second Regular Session)
County officials compensation shall not exceed limits provided by law or as established by the proper authority. The fiscal effects of this proposal depend upon actions taken by the general assembly or by county governments subsequent to the adoption of this amendment.

CONSTITUTIONAL AMENDMENT NO. 6

Submitted by the 83rd General Assembly (Second Regular Session) State treasurer to be custodian of state funds; nonstate funds to be invested for benefit of those particular funds; authorizes investment in longer-term federal obligations and in other financial institutions. The added flexibility for investment of state funds by the treasurer may generate additional earnings.

CONSTITUTIONAL AMENDMENT NO. 8

Submitted by the 83rd General Assembly (Second Regular Session) Clarifies horseracing amendment. Authorizes local option therefor and provides for changes to be made by law. The proposal will not immediately affect revenues of the state or of any political subdivision. Increases the possibility of tracks in Missouri and could produce future revenues.

CHARTER AMENDMENT NO. 1-A

Public Improvements — Shall the following by approved?
Charter Amendment conforming interest rates on special assessments, local improvement certificates and tax bills issued under the Kansas City Charter with new state statutory provisions on the same subject by establishing a maximum rate, for obligations not in default, in an amount not to exceed the rate on ten-year United States treasury

notes as established at the most recent auction. As submitted by Ordinance No. 59344.

CHARTER AMENDMENT NO. A

Parks and Recreation — Shall the following be approved?

Charter Amendment repealing and re-enacting Section 62 of the Charter entitled Front Foot Assessments providing that the annual front foot assessment shall never exceed the sum of \$1.00 per abutting foot. Such Charter Amendment was recommended by the Board of Parks and Recreation Commissioners Resolution No. 20285 adopted March 25, 1986.

Such proposed removal of Kenwood from the park and boulevard system was recommended by the Board of Parks and Recreation Commissioners Resolution No. 20241 adopted Jan. 13, 1986. As submitted by Ordinance No. 59438.

CHARTER AMENDMENT NO. D
Parks and Recreation — Shall the following by approved?
Charter Amendment authorizing the vacation of Tiffany Springs Parkway from Amity Road to I-29 as established by Ordinance No. 39446 upon the dedication and construction of a realigned Tiffany Springs Parkway. Such proposed Charter Amendment was recommended by the Board of Parks and Recreation Commissioners ResolutionNo. 20200 adopted May 28, 1985.



SEPTEMBER IS MEMBERSHIP MONTH

Since we are a not-for-profit, 501(C)(3), your contributions are tax-deductible. You may wish to write a check for more than your designated dues.

When you receive your 1986-87 membership cards, you will notice the change in color. We intend to use a different color each year; however, friends of the neighborhood will always receive a white card (non-voting).

The purpose of the colored cards is to enable us to recognize paid members. When you attend general meetings and participate in any voting, by raising your card for your 'yes' or 'no' vote, we will be able to confirm paid memberships (and the right to vote). Only paid members may vote, and there is only one vote per membership paid. If there is more than just yourself in your household, each person needs to pay their membership if they wish a separate vote.

The new cards will be wallet size and will be convenient to carry. If you haven't received your card in the mail after having paid your 1986-87 membership, call the treasurer to confirm payment. Arrangements may be made to pick up your card at the October meeting.

You will need your card to vote at the October meeting for general elections.

This past year we did not need to conduct a fundraising activity in the spring or summer because so many of you paid your dues. Let's make it a traditionpay your dues and we will have more time to concentrate on important neighborhood matters rather than on how to make ends meet.

CRIME ALERT ISSUED

Due to the generosity of Swartz Printing and Consumer Printing, the Association was able to distribute 2100 copies of a "crime alert" notification, printed in red ink, to households in the neighborhood. Many of the newsletter carriers distributed it immediately and others will be putting the alert with this newsletter.

If you see anyone peering into windows or other suspicious activity, call 911.


Do not undress in front of open windows or sleep in front of open windows.

IT'S A BIRD, IT'S A PLANE ...

It's a Southmoreland SUPER-HERO! Sean Young, 3900 block of McGee, and Scott Pittock, 4100 block of McGee, don't wear blue body tights with a big red "S" on the front, but they do help fight crime in our neighborhood. Last month when they witnessed a purse-snatching near 39th and Main Streets, they both gave chase and cornered the culprit in a fenced lot. They recovered the victim's purse and held the snatcher until the police arrived to make the official arrest. Good work, guys! We're proud of your willingness to be *involved* citizens!

And for those of you who want to help but aren't sure whether to give chase, Bob Hoyes, Southmoreland's Crime Prevention Committee Chairman, passes along alternate suggestions from the Kansas City, MO., Police:

- Following a suspect at a distance may enable you to see what car or house he or she enters, thereby obtaining a license number or address which you can give to the police. Even one piece of identifying information that can be traced helps the police immensely.
- 2. Call 911 if you suspect a crime is in progress or has just occurred. The police are more likely to apprehend the culprit if a prompt report is made.
- Get an accurate description of a suspect if at all possible. If the police know the general physical description of a suspect, they may be able to pick him or her up in the area much sooner.

AMENDMENT #5

On November 4th, we return to the polls to vote on many issues. Among those will be "Amendment #5".

In a nut-shell, what this is all about is being able to use Special Benefit Districts. This is a state-wide issue, to amend the Missouri Constitution, but will interest Kansas Citians on a neighborhood and block level.

Here is how this Special Benefit District would work: Let's say that your street needs a new sewer. A petition would be circulated which would explain what the project would be, its total cost, precisely how much it would affect your property taxes and for how long. Two-thirds of the property owners involved in the project must sign the petition, otherwise the project does not happen.

The advantage to this mechanism is that the whole city does not have to vote on issues which relate to designated areas. If a neighborhood needs lights, sewers, curbs, sidewalks, parks, bridges, etc., then only the property owners involved decide how their area will look.

This bill has been three years in the making and was approved in Jefferson City by a wide margin.

As with all issues, we urge you to read and study what you are voting on before you cast your ballot. Informed voters are smart people.

POST NO BILLS

This means that it is against the law to put flyers on poles or trees. You may not put up yard or garage sale signs — even if you INTEND to go back later and remove them!



TRASH AND GARBAGE

Due to the tenacity of people such as Councilman Jim Heeter, Administrative Assistant Tracy Troft, Councilman Jerry Riffel, City Attorney Galen Beaufort, Public Works Supervisor Don Ewbanks and Southmoreland's Ruth Allen and Suzi Lockett, Ordinance No. 59943, Chapter 16, entitled "Garbage and Trash" was rewritten and took effect October 6, 1986.

This ordinance now prohibits: Putting trash out streetside for collection earlier than 3 p.m. the day before the scheduled collection date, placing of one's trash in another person's receptacle or on their property; scavenging of separated recyclables from refuse containers (with exception for law enforcement officers); location of refuse containers within 8 feet of the front street line for commercial refuse.

This ordinance requires: containers 7 cubic feet or larger to have owner's name and phone number printed on the front and back in lettering 1 inch or more in height; individuals who because of undue hardship, advanced age or physical limitations to receive a permit from Public Works exempting them from compliance.

Complaints of violators should be directed to **Action Center - 274-2222.**

VOTE NOVEMBER 4th!

Keep in mind that there are some important issues to vote on this November 4th.

Proposition No. 1, under *City Subjects*, is a specialized service fee that will be charged only to those, after inspection and notice, do not maintain their properties to minimum city standards. Only violators who cause the inspection will pay for the service.

Missouri Constitution Amendment #5 will allow neighborhoods, blocks or individuals to seek improvements through a special benefit district which they would pay for without having their request go to a citywide vote.



RAPE ALERT!

As we are sure you are aware, there have been a number of pattern rapes in the Westport area during the past year. Until August of this year, the rapes were occurring west of Main Street, primarily in the West Plaza neighborhood. However, the last two rapes have occurred in Southmoreland, and we have no reason to believe they will stop until the perpetrator is caught.

The first of the two Southmoreland rapes took place on August 17 in the 400 block of East 42nd Street, and the second on November 5, in the 200 block of East 43rd. The rapist(s) is a black male, approximately 5'7"-6'0" tall of muscular build. Although the attacks generally happen between 11:00 p.m. and 3:00 a.m., the most recent rape took place around 9:30 p.m. The perpetrator wears a ski mask and threatens his victims with a knife. He generally enters through an open window, unlocked door or some other area of easy access. He has been known to attack victims outside their home or apartment and take them to a nearby vacant building.

Only YOU can stop these rapes. Keep the area around your home/apartment well lit and always be aware of your surroundings. Keep doors and windows locked at all times. Never undress in front of a window. If you believe your windows do not have sufficient locks, the neighborhood association can help you. For more information, contact Dave Lockett at 931-0308.

Above all, **BE SUSPICIOUS**. Call 911 any time you suspect trouble of any kind. Do not open your door to someone you cannot identify. The responsibility for preventing crime lies with each one of us, not only potential victims. Think about what could happen if you don't report suspicious activity to the police.

ASHCROFT PROMOTES AMEND. #5

Governor John Ashcroft and other dignitaries gathered with area residents at the northwest corner of Southmoreland Park October 29 to discuss Amendment #5 on the November 4 ballot. Bob McGregor of the K.C.Chamber of Commerce served as moderator. Speakers included State Senator Harry Wiggins, Jay Dillingham, Mayor Richard Berkley, Suzi Lockett, and Governor Ashcroft.

Although the amendment did not pass, the issue is likely to be debated again. Your October newsletter explains how the amendment could be used to finance neighborhood improvements with taxes to be borne only by the involved property owners, who would request and vote on the improvements.

HOW TO BE A GOOD NEIGHBOR:

Contribute canned food or staples to your church food drive, or take it to a center such as the Salvation Army. If you or your family members have warm clothing no longer being used, or if you have an extra usable blanket, drop these off at collection points during December.

Remember the birds with seeds, not bread, which they cannot digest.

Turn on your front porch lights at dusk to make your street safer.

When that first snowfall comes, get it cleaned off sidewalks before it becomes ice.

Get acquainted with new neighbors — they may be far from family and old friends.

Keep the spirit of Christmas alive in your hearts all year!
