NEW AREA HEALTH FACILITY OPENS

St. Mary's Hospital of Kansas City and the Hyde Park Medical Group have opened offices in the newly remodeled Hyde Park building at 39th and Main Streets. The building will also house a fullservice pharmacy and a dentist's office.

The Hyde Park Medical Group is composed of physicians covering a variety of specialties including internal medicine, obstetrics/gynecology, and family medicine. The St. Mary's Hospital Health Corner provides rehabilitative services in the form of physical/occupational therapy on an out-patient basis. Howard Stark Pharmacy will operate the pharmacy facility, and Dr. Michael McCunniff will provide general dentistry services.

The renovation of the building, originally built in 1916, is part of a major effort to renovate the Main Street corridor from Crown Center to the Plaza. Many groups are doing work along Main Street to bring about revitalization of the area. According to Bill Rose, Hyde Park Medical Group business manager, the medical group is interested in the area's development, and would like to pursue further projects at sites in the 39th and Main Street vicinity.

RENTERS, TOO, CAN CUT UTILITY BILLS

Renters usually can't cut their energy costs as easily as homeowners but that doesn't mean they must reconcile themselves to their current bills.

Apartment dwellers and other renters can take several steps to cut utility bills.

The cost-saving measures include carefully selecting a rental unit, reducing use of energy, and working with the landlord to make the building more energy efficient, according to Missouri Cooperative Extension service home economists. Many of the cost-saving measures for home-owners can also save money for renters.

There are several factors to consider when looking at an apartment in which you would pay your own utility bills:

- The type of heating system the apartment has and the fuel it burns.
- Whether you can control the temperature in the apartment.
- Features such as the number of windows in the apartment and which floor it is on.
- Whether the apartment has a southern or northern exposure. A southern exposure makes an apartment easier to heat.
- The management's interest in energy conservation.

Finding an apartment where all utilities are paid by the landlord may not be as attractive as it seems.

"If utilities are included, the renter can expect to see their rent go up more often," said Jamey Hatch, family economics and management specialist for the extension service.

Renters generally pay most of their own utility bills, according to utility officials and housing organizations. Rising energy costs, regulatory agencies and utility companies all have encouraged individual utility bills for tenants.

- (d) on a crosswalk.



ZONING REGULATIONS UPHELD

On September 27, 1983, Mr. Stephen Keller requested a zoning variation of 160 square feet in order to legally add a basement apartment at 3916 Warwick Boulevard. The variance was denied when residents of Southmoreland expressed their concern about the overuse of property in the neighborhood. It has long been established that overuse of a property (adding more apartment units than the zoning regulations permit) leads to deterioration of neighborhoods.

Usually the owner who originally puts in the units maintains the property fairly well. However, the next absentee owner may not find it financially viable to spend money on maintainence or to properly supervise the use of the property.

The property begins to look a little shabby, so the owner next door decides that since this property is depressing the value of his home he cannot afford to put money into it for needed improvements. The home owner across the street may decide that he does not want to live across from a deteriorating property where tenants park in the front yard and trash accumulates. He decides to sell to a buyer who is going to subdivide the house into rental apartments.

This trend is very difficult to stop and often leads to the demolition of some of the deteriorated properties. Southmoreland Neighborhood Association has consistently taken a firm position of enforcing the existing zoning regulations in order to stop a trend of deterioration in our neighborhood. This position has lead to the removal of many illegal apartment units in parts of the neighborhood.

Where this has occurred, new home owners have been willing to reinvest in the area and upgrade the houses. Property values have increased and the trend of deterioration has been turned around. We look forward to further improvements in our neighborhood in order to make it one of the most desirable mid-town locations.

Mr. Keller applied for a second hearing before the Board of Zoning Adjustment. The hearing was scheduled for November 22, 1983. At that time Mr. Keller's attorney withdrew his application.



MAIN STREET CORRIDOR

The Main Street corridor is a two-mile commercial area which goes through the center of the Westport community. It includes large and small businesses, schools, churches, homes and apartments. Over 200 businesses are in the corridor, ranging in size from unique "mom and pop" stores to the national headquarters of H & R Block and Sutherland Lumber Companies.

In a cosmopolitan atmosphere, Main Street offers a wide variety of places to do business. It has excellent public transportation, and carries over 30,000 cars a day.

Financial services are offered by American, Broadway-Merchants, Republic, and Westport Banks, all of which have strong commitments to the community.

Two historic districts indicate the rich architectural heritage of Main, and distinctive new buildings can be seen at 47th, 44th and 31st Streets.

Main Street is part of the Broadway-Gillham Neighborhood Association and Southmoreland Neighborhoods, where gracious older homes have been restored by people who recognize the convenience and amenities of urban living. It is near the Nelson Art Gallery, major hospitals and Westport Square.

In 1984, new development and business will continue to be the overall goals for the Main Street Corridor Development Corporation.





THE ACTION CENTER

The Action Center was one of several ideas to emerge from a 1973 study by the Midwest Research Institute to determine how communications might be improved between City Hall and citizens, and within City Hall itself. The City Council endorsed the idea, studied various ways of implementing it, and in October of 1973, decided upon the Action Center. It went into operation about five months later. The Action Center, which is part of the city manager's office, currently has a nine-member staff and an annual budget of \$175,000.

The Action Center is a one-stop information and assistance office designed to serve as a bridge between citizens and their city government. Citizen aides are specially trained to answer residents' questions, act on complaints and service requests, and solve problems related to city government.

A resident may call, write or visit the Action Center on the first floor of City Hall. If he has a complaint or problem, a citizen aide takes personal responsibility for it and contacts the appropriate city official or department. The complainant is guaranteed a response and is told when it can be expected. If the complaint requires additional time, the complainant receives periodic status reports until the problem is solved or an acceptable explanation is provided. The Action Center mails each complainant a postcard after final resolution of the service requested. An average 81 percent of those responding have rated the quality of the service received as acceptable, good or excellent. The speed of service has been rated acceptable to excellent by 83 per cent of those returning cards.

The Action Center receives an average of 800 inquiries per week from citizens. Sixty-five per cent are for information and 35 per cent are complaints or requests for service.


The most frequent subject of complaints concerns substandard maintenance of private property. The second most frequent subject is street maintenance. Other subjects of complaint, in order of frequency, are weed control; abandoned or dangerous buildings; planting and removal of street trees; animal control; and trash collection.

Citizens can request help or report a problem by calling the Action Center from 8 a.m. to 5 p.m. weekdays at 274-2222.

On Thursday, September 20th, twenty-two year old Ronnie Trotter was convicted of first-degree murder and armed criminal action in the December 13th, 1983 slaying of police Officer Phillip A. Miller Officer Miller was shot while answering a burglary call at Westport High School.

The Jackson County Circuit Court jury recommended that the defendant serve two life sentences.

ZONING VIOLATIONS CITED

Frank (Sandy) Jennings was recently convicted in Jackson County Circuit Court of violating the

city's zoning ordinances by maintaining too many living units in his properties at 4315 Warwick, 206 E. 44th and 4328 McGee.

In testimony at his trial, Sandy told the judge that there are several other houses in the neighborhood which have multiple living units. Sandy's attorney submitted a list of addresses south of 43rd Street which allegedly have more units than allowed by the R-2 zoning.

The judge instructed the city's attorney to investigate these other alleged violations and they have done so. One had already been cited by the city and action has started against it. Three others were determined to be possible violations and will be cited.

Our neighborhood association has long believed that many of our houses are over used and that this causes problems with parking, noise, lack of maintenance, etc. We will be working with the city to enforce the zoning ordinance.

SAILORS PROGRESS REPORT

After discussions with Kansas Citians and their City Council representatives, Brush Creek Redevelopment Corporation has submitted a revised plan for its mixed-use development. The revision calls for reductions in height and square footage. The project has been reduced by about 500,000 square feet. The tallest building has been scaled down from 52 to 43 stories. Three other buildings have been reduced to 38 and 34 stories for the residential buildings and 34 stories for the combination office/hotel building.



Constitutional Amendments (Vote Yes or No)

CONSTITUTIONAL AMENDMENT NO. 1

Submitted by the 82nd General Assembly (First Regular Session)

Any local government retirement system may provide cost of living increases to retirees provided the system is actuaraially sound. Any cost norease would depend upon the benefits granted and the method of funding them, wholly subject to determination by local units of government.

CONSTITUTIONAL AMENDMENT NO. 3

Submitted by the 82nd General Assembly (Second Regular Session)

Medical benefits for dependents of state officers and employees and dependents of employees of local governments may be authorized by law. Cost to state and local governments for employee health insurance benefits will depend on provisions of laws authorizing benefits and upon insurance plans adopted by those governments.

CONSTITUTIONAL AMENDMENT NO. 5

Submitted by the 82nd General Assembly (Second Regular Session)

State lottery authorized. Permits legislature to set certain standards. Provides for division of funds received. There would be no cost to the state or local governments as all expenses would be paid from revenue derived from lottery proceeds.

CONSTITUTIONAL AMENDMENT NO. 7

(Proposed by Initiative Petition

Authorizes pari-mutuel wagering on horse racing; preates Missouri Horse Racing Commission; creates special fund a located to Commission, certain educational programs, horse research, and prizes; allows voters of each county to prohibit pari-mutuel wagering locally. Commission's costs, \$200,000 to \$500,000, will be borne by state until proceeds from wagering are realized. Estimates of state proceeds range from \$12 million to \$30 million per year depending on rules and laws passed.

STATUTORY MEASURES PROPOSITION B

(Proposed by Initiative Petition) (Vote Yes or No)

Permits charging consumers for certain costs of electrical plants abandoned due to lack of approved waste disposal or other causes; requires certain rate increase deferrals; prohibits certain costs overrun, excess capacity and nuclear plant charges. Administrative costs to the public service commission are estimated at \$370,000 for the first two years. Further administrative costs, legal costs, and revenue losses to state and local governments may be substantail.

JACKSON COUNTY PROPOSITION NO. 1

(Vote Yes or No)

SHALL THE FOLLOWING BE APPROVED?

Golf course fees, recreation and sports activity fees for new, expanded, and existing recreation programs offered by the County Park and Recreation Department (such as softball, soccer, fitness classes, art classes, and others offered by the County). The proposed fees are set set forth in Ordinance #1238. These activity fees are paid only by those persons participating in the program; and all revenue produced will be used by the program from which it was generated.



NEW ORDINANCE LIMITS NIGHT CONSTRUCTION

Kansas City residents who live near construction projects should find it easier to sleep at night, thanks to an ordinance approved Thursday by the City Council.

The ordinance would require anyone doing construction work between 9 p.m. and 7 a.m. within 500 feet of an occupied residence in a residentially zoned area to first obtain a special city permit. The permit would outline what traffic routes could be used by construction equipment and allowable construction site lighting and noise levels.

In issuing the permit, the city Codes Administration Department also would have to consider the type of construction work to be done and the population density of the residential area affected by the night work.

Emergency construction work, construction work in an enclosed structure and roofing done from June through September are exempt from the night permit requirement.

Several council members said the ordinance was prompted particularly by complaints from south Kansas City and Country Club Plaza area residents about nearby office building construction.
