

President's Award

This month's President's Award is being presented to John Kelley for his noticeable renovation of the corner of 43rd and Oak Streets.

The Kelley complex consists of J & G Grocery, Rollickn' Follicle Beauty Shop, Potpourri Antique Shop, and laundromat and offices.

For the past $3\frac{1}{2}$ years that Mr. Kelley has owned these buildings, there have been improvements — everything from a store front face lift to regulated parking.

Mr. Kelley is an active member of our community and very interested in what is happening to the Southmoreland Neighborhood.

When asked if the new co-op grocery will have any effect on business at J & G, Mr. Kelley pointed out that people should always be cautious whenever they make an investment, and should look for selection.

Because of Mr. Kelley's perserverance in keeping 43rd & Oak looking nice on a constant basis, the President's Award is our way of saying thank you.

Main Street Corridor Development Corporation

The Main Street Corridor Development Corporation was formed in October, 1981 to carry on the Main Street revitalization process. Dennis Pierce has been elected to a three-year term on the Board of Directors as a representative of Southmoreland.

The purpose of the Development Corporation is to promote economic development in the Main Street Corridor and to combat community deterioration through improved business, improved utilization of land and buildings, and increased employment opportunities. As a result of these efforts, there are several projects in process on Main Street.

A Facade Rebate Program will encourage property owners to improve their storefronts through a 40% rebate for expenses.

The Missouri Neighborhood Assistance tax credits allow up to a 70% credit on Missouri taxes for money spent on approved exterior improvements.

The Development Corporation has requested up to \$750,000 in Community Development Block Grant moneys for commercial revitalization in the Main Street Corridor.

New Curbs and Sidewalks

Construction will begin in a few weeks on the last phase of our curb and sidewalk project. The streets included in this phase are Warwick Boulevard (both sides) — 43rd to 44th; Walnut (both sides) 43rd to the dead end in the 44th block; and 44th Street (both sides) — Main to Warwick. This work is being

done under a Community Development Block Grant — curbs, driveway cuts, and corner radii will be paid for by the grant, sidewalks will be paid for by the property owner.

Several months ago property owners were sent letter regarding this project. If involved property owners have any questions before construction begins or during construction, please refer to your letter for person and telephone number to contact at Public Works.

This is the last phase of a three year project to replace all substandard curbs and sidewalks within the Neighborhood. It was through the unending efforts of Ruth Allen and Jim Watt that our neighborhood was successful in achieving this goal. Many thanks are extended to them for the hundreds of hours that they both put into following this project to its completion.

DELINQUENT LAND TAX LEGISLATION HOUSE BILL 1441

County, city and state elected officials have been invited to participate in this informational session to explain the importance of this legislation to you and your neighborhood.

Delinquent Land Tax Legislation, HB 1441, has been introduced in the 1982 General Assembly. This legislation would revise the present state law governing delinquent land tax procedures and foreclosure on properties by reducing the effective time period before the county could begin foreclosure procedures from **four** years to **two** years.

Benefits of the Proposed Law

- 1. Taxpayer would be better able to deal with twoyear delinquency rather than the current fouryear delinquency.
- 2. Neighborhoods in the core of the city would become more stable as properties could be recycled sooner and preserved through rehabilitation.
- 3. Abandoned properties could be recycled quicker.
- 4. Decrease property exposure to arson, vandalism and theft.
- 5. Increase the pressure on absentee landlords to pay taxes and maintain property.
- 6. Decrease costs and increase revenues for all taxing authorities, especially schools.

Please attend this informational session to learn why this legislation is crucial to the stability of Kansas City neighborhoods.

Kansas City citizens are planning a trip to Jefferson City to show their support for this legislation. It will be February 16, 1982. We need people and transportation.



Home Protection Tactics

Once you've established the security weaknesses of your home from a thief's-eye view, you can take many precautions to minimize risk and impart the message that your home is not an easy target. Of course, your basic line of defense is a reliable and burglar-resistant set of locks aided by an alarm system. Here we offer some basic antiburglar advice.

- 1. Install outdoor lighting to illuminate your entranceway, garage area, or any place where a prowler could lurk undetected. If possible, install these lights high in the eaves of the roof to prevent tampering. Keep your house number lighted and clearly visible from the street so that the police, if called, can find the right place. Leave these lights on all night for best protection.
- 2. Close all blinds and curtains when darkness falls. This simple procedure prevents would-be intruders from figuring out who is or is not at home or gaining any other useful information about your habits. If you are home alone, you can disguise this fact by keeping the lights and/or radio on in another room.
- 3. If you go out for the evening, leave some lights and a radio on. Mechanical timing devices that turn your lights on and off in your absence are an extremely effective means of giving the appearance that the home is occupied. They are available at appliance and hardware stores. As you step out the door, call back to an imagined person inside the house "See you later don't eat all the ice cream" or something of that nature.
- 4. If you live in an apartment, keep a spare lightbulb to replace any that burn out in your hallway or entranceway. If you return home and find your entranceway completely dark, don't enter your apartment alone.
- 5. Never publicize your absence by leaving a note on the door.
- 6. If possible, avoid regularly scheduled absences. Burglars can have a field day if they know that you are always out between certain hours.
- 7. All outside doors should be equipped with 180-degree safety viewers to enable you to see your caller without opening the door. Chain locks, unless they are unusually sturdy, can be easily broken.
- 8. Purchase a "Beware of Dog" sign and place it in a visible location even if you don't own a dog.
- 9. Place home-alarm-system decals at your front and rear entranceways and on windows. These may be available at your local hardware store. If not, have a printer make them for you.
- 10. If you have a garage, keep it locked at all times.
- 11. Ladders or other equipment that might be useful to an intruder should be kept under lock and key.
- 12. Develop a neighborhood watch or block association.
- 13. Using an electric etching pen, place personalized identification numbers on your valuables. Check with local police to determine the system of numbering they recommend. Thieves know it's more difficult to fence stolen property that is so marked.

Car-Protection Tactics

Stealing a car is often much easier than burglarizing a home. Whereas the house thief has to guess what (and who) is in the house, the car thief has only to walk up and look at the car to know that it's empty. At the same time, the car thief knows that most people are concerned only with their own cars. The neighbor of a person whose home is being burglarized might call the police, but the average person has less interest in the cars in his or her neighborhood. Thus the car thief can work almost with impunity.

Professional car thieves understandably favor the more expensive luxury cars, but no car, no matter how old or dilapidated, is safe from theft, and someone looking for a joy ride will select the first available vehicle. There is no sure way to prevent auto burglaries, but a number of precautionary measures can help.

- 1. Don't leave your keys in the ignition. It has been estimated that more than half of the car thefts in the United States happen because keys are left in the ignition. Take your keys with you, and always lock the car when you leave it. Make this a habit.
- 2. Keep your ignition key on a separate key chain, not with your house and/or office keys. If an unscrupulous parking-lot attendant has both your car and house keys, he can have the house keys copied, trace your address through your license-plate number, and use the keys to burglarize your home.
- **3.** Keep your trunk key separate from your ignition key. That way, if you park in a commercial lot, the contents of your trunk will be comparatively secure.
- **4.** Keep a spare set of car keys with you. If you lose one set or lock yourself out of your car, you'll be able to get going much more quickly and cheaply.
- 5. The best place to leave a car is in a locked garage. The car itself should be locked, and the garage lock should require a key to open it from both the inside and outside. Garage windows, too, should be securely locked.
- 6. Never leave valuables in the passenger compartment. Keep all packages locked in the trunk.
- 7. Don't depend solely on auto burglar alarms. Once people install these devices in their cars, they tend to ignore some of the foregoing safety measures. And, since many auto alarms go off for no apparent reason, neighbors and passersby treat them more as a nuisance than an indication of trouble.


Many Thanks

Our enthusiasm was well founded. Broadway National reconstructed the discotheque building into a banking facility attractive both outside and in on June 27, 1981, opened its doors staffed with personnel who became immediate friends of the neighborhood — Phillip Hadley, Vice President of the Broadway National Bank and Manager of the Main Street Branch, Randy Vance, Branch Bank Assistant Manager, Patricia Catron, Cashier, and a number of attractive, pleasant tellers.

The branch is a full-service bank offering free checking accounts, savings accounts, safe deposit boxes, loans, drive-in facilities, and convenient hours.

The personnel are full-service friends — they will help untangle your financial questions, listen patiently to your stories both funny and sad, staff houses for a tour, attend meetings, loan out the parking lot for a good cause, and become members of the association.

The weeds have become landscaping and the trash and litter disappear daily.

The President's Award is Southmoreland's way of saying "We are very happy you are part of our neighborhood."

Rockhill Manor

Rockhill Manor, 4235 Locust, is a privately funded, licensed nursing home and residential care facility, providing services for anyone over age 21 requiring assistance in personal skills.

According to James Haritgan, the administrator, Rockhill Manor houses 130 men and women involved in a resocialization program. These residents are not harmful or outwardly aggressive, nor a danger to themselves or others. Only a few residents are mentally disabled; however, 40% of the residents are employed full time and all are active members of society.

Rockhill Manor has developed from a residential hotel in 1979 to an adult boarding facility and through improvements to what is now a residential care facility.

A residential care facility means that by learning to care for themselves on a daily basis, the residents are achieving their long range goal of becoming self sufficient. Rockhill Manor provides room, board and health services for these individuals until they meet their goals.

Main Street Revitalization

Over the next few months, you will see alot of improvement in the physical appearance of Main Street businesses. The Main Street Corridor Development Corporation has put together a package of financial incentives for private business owners to rehabilitate their storefronts and building facades.

Four neighborhood banks (American, Broadway, Republic, and Westport) have agreed to make loans totaling \$200,000 to finance projects meeting certain design standards. The basic intent of the standards is to return the facades to their original design where feasible.

Upon successful completion of a facade rehabilitation, each business will receive a rebate of 40% of its cost up to \$1,500. This rebate will be paid from a fund of \$80,000 recently appropriated for this purpose by the city of Kansas City, Missouri.

Projects underway include The Colonial Hotel, 3832 Main; Love Records, 3941 Main; and The Coop Grocery, 3967 Main. Before the entire quarter million dollars is spent, over 50 rehabilitations will have been completed.

The transformation of the old Netherlands Hotel into Hawthorne Plaza at 3835 Main is progressing well. Occupancy of the 161 elderly housing units is scheduled for July 1st. For information regarding leasing of the apartments, contact Shawn Michael at 531-1470. Next door south, on the corner of 39th and Main, The Hyde Park building is being remodeled as medical offices and other services for the residents of Hawthorne Plaza.



Four years ago, if anyone had asked Cheryl & Les if they had wanted to live on a dairy farm, they probably wouldn't have even listened to the sales pitch.

But when their home on 44th Street was built in the 1870's, that is exactly what it was.

Tender loving care has been used by all four owners since then. Outside, the attractive New York slate roof, shrubs and even a moat which yields strawberries presents to the passer-by a feeling of care and tranquility.

Inside is a feast for the eyes. The twelve foot ceilings and floor plan are automatically appealing; but the working fireplaces and "hidden" storage areas are some of the great surprises.

The Southmoreland Neighborhood says thank you to Cheryl & Les Matthews for preserving so well part of our neighborhood's history. This residence was on the Kansas City Chapter of the American Institute of Architects tour in 1980.

New Curbs and Sidewalks?

The contractor constructing sidewalks, curbing and driveway cuts in our area will clean up the bulk of the debris when he completes the project, but final cleanup will be the responsibility of the property owners in the project area. Public Works suggests that as soon as the concrete has a good set the new areas be swept off and hosed down.

When the sod is laid the contractor has responsibility for some watering, but the property owner can do much to assure the sod will make a good stand by keeping an eye on it and helping keep it watered.

DO NOT use salt or chemicals on the new concrete the first winter. **Sand** is the **only safe thing** to use on new concrete the first year. Even chemicals which are advertised as being safe have been found to do much damage to new projects.

Protect your investment — your dollars paid for the sidewalks—your tax dollars paid for the curbing and driveway cuts.


Our sympathy to the family and friends of:

NOISE ... NOISE ... NOISE

The city's new noise control ordinance has been successfully tested in our neighborhood. Among other provisions, the new ordinance restricts the hours during which trash trucks can operate in residential neighborhoods. The trash company hired by J & G Market, 43rd & Oak, was disturbing neighbors by emptying dumpsters between 4 and 6 a.m. After notice by the city, the company agreed to change the time of their pickups to after 7 a.m.

The city council has declared that the citizens of Kansas City have a right to an environment free from excesive noise. Under the new noise ordinance passed by the council, the following are illegal as well as outright inconsiderate:

- 1) Keeping any animal which frequently or for long periods makes so much noise as to disturb or annoy a reasonable person of normal sensitivities across a residential property line.
- 2) Operating power tools (such as lawn mowers) outdoors in a residential area between 10 p.m. and 7 a.m.
- 3) Loading or unloading of garbage cans and other such containers in a residential area between 7 p.m. and 7 a.m. or operating the compactor of a trash truch within 500 feet of a residential area between 8 p.m. and 7 a.m.
- 4) Playing any radio, T.V., stereo, etc. between 10 p.m. and 8 a.m. in such a manner as to disturb or annoy any reasonable person of normal sensitivities on another property.
- 5) The sounding of a motor vehicle horn except when necessary for reasons of safety.

The ordinance also sets maximum noise levels for motor vehicles and motorcycles, and requires mufflers to be in good working condition.

An ordinance like this shouldn't be necessary among civilized people. Unfortunately, some people are less civilized than others and have to have rules to keep them from disturbing other people. You do have a right to an environment free from excessive noise. Exercise your right.



Southmoreland Applies To The Kansas City Landmarks Commission

The Southmoreland Neighborhood Association has filed an application with the Kansas City Landmarks Commission to have a part of the neighborhood declared a local historic/architectural district. The commission staff discussed the idea with the general membership at our May meeting, and has met with the executive board on two other occasions.

The area to be considered is from the West side of Warwick Boulevard to Rockhill Road and from 43rd Street South beyond 45th Street. This area of architecturally distinctive houses was built from 1900-1915 for some of the city's foremost business leaders. Many of the homes were designed by prominent architects.

Designation of this area as a local historic district could be of great value to the whole neighborhood. Besides the public recognition and increased sense of pride we would share, we would also obtain the protection of the Landmarks Commission against further incongruous intrusions and alterations. For depreciable properties within the district, there are also federal tax advantages.

Four other neighborhoods have been declared local historic districts: Janssen Place, Rockhill, Union Hill and the Simpson-Yoeman/Countryside area East of Loose Park.

We will be arranging meetings with property owners in the proposed area to explain the advantages of historic designation and to answer any questions.

Everyone at the general meeting felt that Walnut should remain totally residential, and were ready to sign a petition to this effect concerning the purchase of land and rezoning to build the motel.

We will want to get the ball rolling on purchasing signs for the target area, so please make an extra effort to be there. Neighborhood crime watches **do** work. A would-be burglar was nabbed by police after being called by an alert resident the morning after our first neighborhood watch meeting.



Southmoreland Historic District

On July 28, the Neighborhood Association appeared before the Kansas City Landmarks Commission to have a portion of the neighborhood declared a Local Historic District and placed on the Kansas City Register. The Landmarks Commission agreed unanimously that the area from 43rd to 44th and from the west side of Warwick to Rockhill Road is a very important collection of homes, not only from a historical perspective, but culturally and architecturally as well.

The district was cited by the Landmarks Commission Administrator as "one of the principal residential areas for prominent leaders of the Kansas City business community following the turn of the century", with "architecturally distinctive homes designed by a number of notable Kansas City architects."

The application will now go to the City Plan Commission and then on to the City Council for final approval. Dennis Pierce is to be commended for the extensive research he has done on each of the 61 properties in this District.

MOTEL DEFEATED

The 4300 block of Walnut is a nice, quiet residential street that has seen recent revitalization. There are now seven resident owners in this block and several of the rental units are occupied by long-term, stable tenants. The block has new curbs and sidewalks, and a newly resurfaced street. The houses are charming and progress is being made in rehabilitating the remaining eyesores.

Three of the houses on the west side of the street have been allowed to deteriorate badly. They are owned by a local realtor who decided to replace them with a 90 unit motel which would have wrapped around the Karnopp building with only 100 feet on Main St. and 150 feet on Walnut.

The Southmoreland Neighborhood Association Executive Board voted to oppose this intrusion of Main Street commercial interests into the residential area. At a public hearing before the City Plan Commission, Dennis Pierce, our zoning committee chairman presented the neighborhood's case against changing the zoning from residential to commercial. Petitions opposing the change were presented to the Commission with 197 signatures of neighborhood residents and property owners. nearly 40 neighbors attended the hearing to register their concern.

After hearing the concerns of the neighborhood, the Plan Commission agreed that while development of Main Street is vitally important, the sacrifice of this residential street was not warranted. One Commissioner explained his vote against the change by stating that in his opinion, this developer chose expedience by buying up residential properties rather than the more appropriate Main Street properties.

Our message was heard: This neighborhood wants good quality development on Main Street, but wants it to stay on Main Street; intrusions which would destroy the quality of the residential streets are inappropriate and unnecessary.

Many of the neighbors whose lives would have been disrupted by this motel have expressed their gratitude for our help in defeating this ill-conceived project. We pass this gratitude on to all of you who helped, especially those who took time from their busy schedules to attend the public hearing and convince the city that we are a neighborhood of people who care enough to stand up and be counted.

The American Institute of Architects will conduct a tour of the Gallery Area. Three residences and one garden will be included on the tour:

The R.E. Bruner residence "Mineral Hall", 4340 Oak Street was built in 1904. Louis S. Curtis was the architect. One of the most interesting features of this house is the semi-circular compound arched entrance with imported mosaics and leaded art glass. The design of the house was influenced by the Art Nouveau movement as well as the Prairie School.

The house was built for a mining tycoon, Rowland E. Bruner. He occupied the house until 1915. The house is currently owned by the Kansas City Art Institute which is using it for office space. The basic floor plan remains intact.

Marrion Gillerlain's home at 4339 Locust was reportedly moved to its present location sometime around 1900. Over the years there were some additions and changes made to the original structure. Three years ago the house was purchased by David A. Stickelber who had it redesigned by Jerome Sutter and Louis Goodman. The home is an excellent blend of contemporary and traditional designs with an overall Georgian Colonial theme.

Mr. and Mrs. Lou Steele's home at 4330 Rockhill Road was built in 1913 as a single family home and continues as such today. The Steeles are the fourth owners of the property, having purchased it two years ago from Bill and Sally Hoover. The Hoovers had done considerable renovation to the house including the use of multiple colors on the exterior to accent architectural features.

Dan Bowman and Jacques Bredius' garden is a hidden treasure at 4320 Rockhill Road. The garden has an in-ground swimming pool, gazebo, fountain, brick patios and extensive plantings. Dan is continually adding to and modifying his landscaping to enhance the warm cozy feeling of an intimate garden.

A special thank you to Phoenix Companies for taking the Adult Bookstore out of our area and making the corner of 39th & Main a pleasant place to be once again.

GRANT MONEY PUT TO USE

The Missouri Housing Department Commission has granted our neighborhood \$150,000 for use in rehabilitation of residences within our boundaries.

Ed & Michael Cockrel have been granted use of some of this money in the purchase of 4331 McGee. It is their committment to renovate this property and decrease the units to a duplex-thereby bringing it into conformity with code restrictions, increasing its value and making it a complement to our neighborhood.




